1.0 Welcome: 7:20 pm. Sheila Perry, President, welcomed members to All Saints' Event Hub.

2.0 **Approval of the Amended Agenda:** moved by Don Stewart /seconded by Neil Thomson CARRIED

3.0 The future <u>All Saints Event Hub</u> was purchased in December 2015. From then on, the 116 year old building has been refurbished/repurposed. The goal is to achieve a balance between public,, office, and spiritual space as well as commerce and new development. "We think every resident of Sandy Hill will find at least one thing that would attract them to this location" said Leanne Moussa.

3.0 Sandy Hill CA:

Sandy Hill / Côte-de-Sable is a bilingual community of 12,500. Significant recreational features are the 15 acre Strathcona Park and 8 acre MacDonald Park, with its stone gazebo. The community's rich history includes resident political leaders J.A. MacDonald, W. Laurier, R. Borden, WLM King and L. Pearson. Université d'Ottawa and thirty embassies are located in the neighbourhood. There currently is a Heritage Inventory project. Six, but potentially 8, heritage conservation districts have been designated there. 853 locations have been designated of being of a culture heritage character.

Acton Sandy Hill (ASH) was created in 1969 in response to a proposed "King Edward Expressway" that was to run through the neighbourhood. ASH won that battle. Its main concerns are: safety, heritage conservation, planning and zoning, transportation as well as the impact of student on the neighbourhood. 3.1 Greetings were received from Chad Rollins (ASH-ACA president) and Councillor Mathieu Fleury (Rideau Vanier). They answered questions.

4.0 Heritage Ottawa (D. Jeanes and L Hoad)

Heritage Ottawa, a registered charity, was established in Canada's centennial year. Its goal is to ensure the preservation of Ottawa's unique heritage character for future generations. Its many

accomplishments, including Doors Open Ottawa, Walking Tours, Heritage Day (third Monday in February), Annual Heritage Forum, Colonel Bye Day, Advocacy and Publications - found at www.ottawaheritage.org, have been recognized in 2016 by the National Trust's Governors' Award and in 2017 by the City of Ottawa's Heritage 150 Award. To celebrate its 50th anniversary landmark year, it's publishing 50 stories of built heritage. Heritage Ottawa awards an annual research or publication grant.

Heritage Ottawa maintains contact with the City of Ottawa's Heritage Department and makes periodic advocacy presentations to the Built Heritage Sub-Committee of the Planning Committee, and to other committees at Council. The sub-committee deals with matters arising from the part IV and V of the Ontario Heritage Act (1990). The City holds a heritage primer every other year.

6. 0 Open Mike on local community issues:

a) Ottawa-wide strategy to support homeless individuals (Vanier CA) [item 10.3: Oct 2017 FCA proceedings]

In the absence of L. Touchant, President of Vanier CA, Councillor Fleury's remarks were informative. He said that he had appreciated the observations/recommendations of the FCA. On November 22, Council approved the Salvation Army's proposal to move to Montreal Road. He understands discussions are being had on the merits of the community appealing to the OMB.

b) Rental registry

It was noted that in the spring 2017, the city of Toronto introduced a rental registry. It was hoped that it would provide protection for tenants, but hold substandard landlords more accountable. While the city of Ottawa does not yet have a comparable registry, since 2011 ACORN Ottawa's housing justice program has helped tenants to make application to the *Landlord & Tenant Board* which has power to order repairs, grant rent abatement or return fees.

c) Hydro Corridors: Vegetation Management (Neil Thomson. Kanata Beaverbrook CA)
Kanata-Beaverbrook's affected property owners (124), and their CA have recently entered an Agreement with Hydro 1 regarding the vegetation management of areas adjacent or in a Hydro 1's corridor (80 foot wide easement). The ward Councillor was actively involved. It was agreed that core to Hydro 1's relationship with residents of the neighbourhood is communication/consultation. This written agreement could serve as a template for other neighbourhoods containing a Hydro 1 or Ottawa Hydro corridor.

7.1.2 Energy Evolution Program & REAL Renewable Energy Strategy:

ACTION arising from Oct 18 proceedings MOTIONs 10.1.1 and 10.2.1: FCA provided input into the pre-budget consultation with the Environment and Climate Protection Committee as directed. Ecology Ottawa, CAFES and the Ottawa Chamber of Commerce were on the same page. The related motion taken up by the committee failed because of a tied vote. It was noted that Committee members and City staff are on notice that a united community is watching.

7.1.3 Ottawa-wide strategy to support homeless individuals:

ACTION arising from Oct 18 proceedings Motion 10.3.1: FCA identified the General Meeting's concern to the Planning Committee. Given that many of the delegations to the Planning Committee over three days of hearings were concerns about best practices in working with vulnerable people, the initiative's fit with the Housing First Strategy of the City and the challenges of integrating a facility in an apprehensive neighbourhood, why was Community and Protective Services Committee not involved?

8.0 Treasurer's Report –Lorne Cutler reported that our book balance remains approximately \$7000. He spoke of revenue of \$1200 and recurring expenses of approximately \$2000. Those who have not renewed were encouraged to do so.

9.0 Committee Reports:

9.1 Communication: Bob is preparing a short survey, from which a report will be prepared by year's end

9.5 Membership: Expanding the benefits of membership is one of our goals. 9.6 Planning:

- OMB Reform (Bill 139) Committee hearings completed on Nov 23, 2017; referred back to the legislature for third reading.
- X R4 Review Staff were to proceed with Phase 1 by this fall, this has been delayed as they don't have internal agreement. Our Committee has asked for a meeting to discuss the status and stated that we would prefer a meeting before they agree internally on how they want to proceed.
- Infill 1 & 2 Review Should have begun by now. Our Committee has inquired with staff on status of this review, and have yet to receive a detailed reply.
- Complete Communities Workshop Our Committee is organizing a half day workshop for Jan 27, 2018 at Tom Brown Arena to begin the discussion for the next Official Plan review with a focus on building complete communities.
- **9.7 Social:** The Art and Culture Community is interested in establishing a relationship. This could be advanced by having it as a theme of a general meeting.
- **9.8 Transportation:** In the remaining days of November and in December, representations will be made to City committees on the budget implication of the recommendations contained in our Response to City of Ottawa's Transportation [see #7.1.1 above TMP]. Our well received report may have additional impact if it were again sent out in 2018 when work has begun on the new TMP.

10.0 New Business:

10.1 Federal Sustainable Development Act: Morley Brownstein [Oct 18 proceedings item # 6.0 b] again observed that the House of Commons Committee on the Environment and Sustainable Development had recently recommended amendments to the Federal Sustainable Development Act. Not contained was a recommendation to include the National Capital Commission (NCC) within its mandate. When hearings are held on these amendments, this recommendation will be made. To strengthen the significance of this recommendation, members are being asked to approve a two part motion:

10.1.1 That the Federation of Citizens' Associations of Ottawa (FCA) urge the House of Commons' Standing Committee on Environment and Sustainable Development, in its study of Bill C-57, An Act to amend the Federal Sustainable Development Act, to amend Bill C-57 by adding the National Capital Commission to the Schedule of agencies subject to the Federal Sustainable Development Act.

10.1.2 That the FCA seek to appear before the Standing Committee accompanying a representative of the Bel Air Community Association to testify in support of the amendment.
