Agenda item 5: Ontario Municipal Board Review

Community groups and individuals with an interest in civic issues or in land use planning are encouraged to participate in a review of the OMB conducted by the provincial government. Submissions are to be received by December 19, 2016. The province has organized a “town hall” on the review to be held in Ottawa on Thursday, November 9 (see <http://www.mah.gov.on.ca/Page15024.aspx> for details).

A review was announced in the summer and the province received unstructured comments prior to formally launching the review with a consultation paper accessible at <http://www.mah.gov.on.ca/Page14965.aspx>. The consultation paper includes 24 questions and to facilitate response to those questions, FCA-FAC has prepared a document with the questions in simple text format which you can open in any word processing package and use as a template in sending in your views.
