- **1. Welcome:** Sheila Perry, FCA President, welcomed members to Overbrook.
- 2. Approval of the Agenda moved by Alex Cullen/seconded by Don Stewart CARRIED
- **3. Overbrook CA:** (a) Introduction to Overbrook by Rawlson King, President, Overbrook C.A. (b) Greetings from Councillor Tobi Nussbaum, Rideau-Rockcliffe Ward (13) Tobi commented on a number of projects on east and west arteries, bike lanes on Beechwood, Montreal Rd., McArthur and connections to Train Yards, Alta Vista and a Community Hub project at Rideau HS site and RRCRC.
- **4. FCA Award Citizen Engagement** presentation to Judy Forrest. Tom Whillans, President of CCCA commented on long term commitment by Judy in the community. Judy shared some early beginnings as an employee of FCA, to assist citizen's groups in the Region of Ottawa, the development of a Centretown Plan and vibrant community work.
- **5.** Presentation: "Housing in Ottawa Balancing the Need for Affordable Housing in our Communities" Lisa Ker (Exec.Director, Salus) and Ray Sullivan (CEO, Centretown Citizens Ottawa Corporation)

Salus supports individuals with mental illness on their journey to well-being and independence by providing quality housing, support services in the Ottawa Region.. Salus provides a wide range of supportive housing options including a transitional rehabilitation program, shared homes and independent living opportunities in communities throughout the city of Ottawa.

CCOC bought its first building in 1975 with \$500 in the bank. Today, more than 50 properties provide almost 1600 units of affordable housing to Ottawa residents. Volunteers and staff believe in the basic idea that everyone should have control over their housing. Over 10,000 are on a wait list for affordable housing. 40% cannot afford housing, 20% spend more than 50% on rent. New, affordable rentals are needed rather than condos.

Discussion and comments included the need to develop criteria for affordable housing in every neighbourhood, near transit, schools, recreation, walkable areas and complete neighbourhoods. Every city must file a 10year plan. Calgary, Vancouver, Toronto and Montreal are examples of city planning models that include community involvement.
