a) Lansdowne Park partnership modifications

A proposed motion has been received from Glebe Community Association as follows:

- Whereas arrangements for the redevelopment of Lansdowne Park were a subject of controversy and vigorous public debate,
- Whereas Council has been informed that financial returns from the redevelopment have been less than envisaged at the outset of the project, and
- Whereas Ottawa Sports and Entertainment Group has indicated that it will propose by the end of June certain modifications to the existing partnership arrangement with the City

***Be it resolved that***

- 1. FCA-FAC inform Council and OSEG that comprehensive public consultation on Lansdowne will be required; that greater transparency on financial aspects of the partnership must feature in those consultations and that such consultations cannot effectively be conducted during the summer vacation period and***
- 2. FCA-FAC request confirmation that Council will deliberate on any proposed changes to the Lansdowne partnership agreement only following public consultation and not prior to October 1, 2019.***

On April 30, a small team of FCA representatives participated along with personnel from the development and building management industries in the first of a series of Official Plan workshops organized by the City. **Planning & Zoning Committee – Ontario Housing Supply Action Plan**

On May 2 the Minister of Municipal Affairs and Housing introduced Bill 108, a wide-ranging piece of legislation with significant implications for land-use planning and municipal finances. **Transportation Committee – Transportation Master Plan – Traffic Demand Management**

The Transportation Master Plan (TMP) is a companion document to the City's Official Plan, and sets goals and policies regarding mobility (walking, cycling, public transit, vehicles). The TMP review workplan is expected to be presented to the City's Transportation Committee in June. The FCA Transportation Committee anticipates holding a workshop for FCA members on the TMP objectives later this fall).

The committee has learned (1) the Origin-Destination Study that normally accompanies a TMP review will not be completed by the 2021 deadline (!). It is expected that the TMP will be revised as the OD results are finalized. (2) A study of best practices regarding Traffic Demand Management techniques (strategies to encourage sustainable modes of travel other than by car i.e. walking, cycling, transit, through the use of such measures as parking rates, congestion charges, road tolls, etc.) will not be considered during this TMP review.

As a result, the FCA Transportation Committee tabled the following motion, to be considered at the May 15 meeting of the FCA:

- Whereas the City's Transportation Master Plan Review will be considering targets to enhance sustainable alternatives to vehicle use, such as walking, cycling and transit, which would reduce the pressure to extend/widen roads through residential neighbourhoods and improve the environment;
- Whereas a review of best practices in other cities regarding Traffic Demand Management measures would inform both City Council and residents of Ottawa of the techniques available that may be considered as a means of helping achieve these TMP targets;

***Be it resolved that***

***FCA recommend to Ottawa City Council that a review of best practices regarding Traffic Demand Management measures be included in the Transportation Master Plan review workplan.***
