## Presentation Summary: CBCs are a replacement for Section 37 monev. The new bylaw is to be tabled at Council in June 2022. Max charge is 4% of land value, applicable to multiple unit residential developments of 5 or more storeys. No double dipping with Development Charges. Can be applied citywide or ward-byward. Expecting 19,300 dwelling units to be subject to CBC charges over next 10 years for an estimated \$35M revenue over that time. CBC revenues are not forecasted to cover growth-related capital costs. Presentation on a draft bylaw expected in April. (B) Slide Presentation by Mary Huang and Warren Waters on the Ottawa Community Benefits Network (OCBN) is available at http://fca-fac.ca/minutes/fca-fac-generalmeeting/ Community Benefits Agreements (CBAs) are different from a CBCs. They are not about raising money for physical infrastructure related to growth. Rather, they are about social and cultural objectives. They are intended to build an equitable, diverse, inclusive, sustainable community, i.e. social infrastructure. **Open Mic:** Lorne Cutler: Will circulate a follow-up memo being prepared by Judith Shane that is focused on how to draft amendments to CA bylaws to be compliant with the new Ontario Non-profit Corporations Act (ONCA).

Morley Brownstein: Flagged that when FEDCO discussed the Residential Vacant Unit Tax. it did not address how seniors and others without computers or who are not computer literate could comply with the filing requirements. Bob Brocklebank: First meeting of the FCA Parkland Dedication WG met recently and expressed concern about the City's cancelation of its planned February public consultation. The City has now announced on its Engage Ottawa web site that additional public consultations will be held in March and April. Elizabeth McAlister: The Manor Park Estates and Fotenn application for a 35 acre redevelopment in Manor Park will go to Planning Committee on February 24th. Members were invited to lend their support in opposition to the proposed level of intensification.
