- · Recognize and support diversity,
- · Support environmental sustainability,

- Promoting the development of Ottawa as a more liveable community of neighbourhoods and as a national capital that is culturally vibrant, diverse, healthy, resilient, inclusive, sustainable, caring, prosperous, civically engaged and well-governed,
- Collaborating with engaged residents, community associations, businesses, governments and others to find innovative solutions to urban and rural challenges and opportunities,
- Advocating for systemic improvements in government process, policies plans and programs that align the FCA's vision and core values."
